We will provide a nurturing and caring environment that will offer your child consistency and security. It is very desirable for us to work with each and every family to build a quality relationship that is beneficial to all, especially your child.

Endless Discoveries strives to meet the needs of the families in our community. Educational, safe daily child care is such a growing need among working families. From Infancy to School-Age, Endless Discoveries holds a higher standard for child care and supporting the community around us by providing developmentally appropriate activities for the children, a safe, loving environment for the families, and a challenging yet fulfilling work environment for the teachers.

## Organized Routines

Endless Discoveries believes in having an organized routine on a day-to-day basis. Each classroom has a scheduled time for inside and outside play, which provides a good balance between active and quiet play. By allowing children to have a set routine, they understand what will happen next even though they are unable to read a clock. With that knowledge, children move smoothly from one activity to the next with little problem.

---

## Outside Play

Our playgrounds are designed with your child in mind. We have playgrounds that are stimulating to the young mind and offer a wide range of physical challenges. Endless Discoveries will remain vigilant in checking the weather among different sources to determine if weather conditions pose a significant health risk; however, we will use the following criteria for spending time outside: If the heat index is lower than 90 degrees = 30-45 minutes; 90-95 degrees = 15 minutes in the sun, then up to 15 minutes in the shade; 95-100 degrees = 5 minutes in the sun, then up to 25 minutes in the shade; 100+ degrees = 10-15 minutes of shade play, up to 4 times per day. If the wind chill is under 37 degrees = 10-15 minutes, up to 4 times per day. Texas Department of Family and Protective Services provides standards requiring children to have two opportunities for outside time every day equaling at least 60 minutes, so please do not request for your child to stay indoors.

## Accreditations & Military Programs

NACCP is an organization comprised of early child care and education leaders, owners, directors, administrators and managers. NAC accreditation offers early care and education programs the opportunity to demonstrate and document quality performance using research-based criteria. NAC accreditation values the rich and diverse tapestry of early care and education programs and the uniqueness of each. NAC's high standards for child care centers help improve the quality of safety, equipment, health policies, nutrition, administration, teacher training, ongoing evaluations, parent communication, and developmentally appropriate settings and activities for children. Endless Discoveries is proud to follow this criteria and become accredited with NAC for Excellence!

**Texas Rising Star Provider:** Endless Discoveries works with the State of Texas and the Texas Workforce Commission to provide quality child care to serve subsidized children and children enrolled in certified facilities such as foster homes. The Texas Rising Star certification is a process of improving the quality of child care facilities that voluntarily meets requirements that exceed the state minimum standards. Through assessment, centers are awarded on a graduated scale which offers three levels of certification (Two-Star, Three-Star, and Four-Star) to encourage providers to attain progressively higher certification requirements leading to a Four-Star level. Endless Discoveries has been awarded 4 Stars! Receiving this certification is not only a huge honor, but provides the parents who use our services confidence that we provide quality care and our staff additional training opportunities.

## Communication

---

It is our desire to have open communication lines with each of you. Endless Discoveries feels that it is important that we have a close relationship regarding the needs of your child. We welcome you to call during the day to talk to your child's teacher, although we may ask if a return call can be made if it is not an emergency and learning activities are going on in the classroom. Additionally, we are available through email; however, if there is a time or date importance, it is always best to call the school. We hope you will feel free to openly discuss any issues that you might have concerning your child's care in Endless Discoveries. As an ongoing effort to improve communication, we strive to provide information in many different ways:

## Enrollment

---

Enrollment will be deemed complete when the following forms are complete, and the registration and first month tuition has been received. The center requests all information pertaining to the child such as legal documents regarding custody and special needs assessments.

- Emergency Authorization
- Enrollment Acknowledgement
- Tuition Express Form
- Consent Form

- Certified copy of most recent custody order (if applicable)
- Tuition Rate Agreement
- Individualized Education Plans (IEPs) or physician developmental plans (if applicable)

# Safety, Security and Health

---

## Training

---

The State of Texas requires all professionals in the child-care field to complete at least 30 clock hours of training per year. All training records and in-house training curriculum are available for review by request. We will complete these hours during two in-service days, President's Day and Columbus Day, as well as during our staff monthly meetings. Endless Discoveries will be closed during the in-service days, so you will have to make other arrangements if child care is needed during those days.

---

## Health and Illness

---

As a requirement by the state of Texas, a member of Endless Discoveries staff will conduct a quick visual and/or physical health check as each child enters the classroom for the day. If any concerns arise, the staff member may choose to take the temperature of the child or send the parent or guardian with the child to a member of management.

If your child shows the following symptoms of illness, they should not be brought to school: Vomiting – Fever of 99.4 or greater – Diarrhea – Sore Throat – Pink Eye – Skin Disorders – Head Lice. Please have your child seen by a doctor to determine if they can return to school. Children who have been ill may return to school if they have a signed doctor's statement, or if they have not shown any symptoms for 24 hours. This includes being fever free for 24 hours without the aid of fever reducing medication. If your child becomes ill while in care, they will be isolated, and pick-up within 45 minutes will be required by either parent or emergency contacts. This is necessary for health and safety reasons. As always we will look at the whole picture; for example, temperament, bowel movements, appetite, etc. We understand that every parent has a very demanding job, otherwise your children wouldn't be here, but we have the responsibility to provide the healthiest care we can for each child.

We ask that all families be open and honest about any illnesses your child experiences. This allows our management staff to track these illnesses and communicate on a need to know basis to the classroom teachers and other families in care. We will take all measures to keep your child's confidentiality.

**Tuberculin Testing Requirements:** If the regional Texas Department of Health or local health authority requires tuberculosis testing for children attending the center, then you must have documentation of the test on file at the center.

**Hearing and Vision Screening Requirements:** The state of Texas requires vision/hearing screening for all four year olds. The verification of the screening must be on file at the center for all children 4 years of age and older.

Due to the nature of business that Endless Discoveries conducts, all families that enroll must understand that there is a risk of exposure to illness. Endless Discoveries takes health and sanitary precautions very seriously and is willing to explain our daily cleaning and sanitation processes. By enrolling your child in Endless Discoveries, you inherently understand that while present in the facility your child will be in contact with children, staff and other families who are also at risk of exposure to illnesses. You must also understand that no list of restrictions, guidelines or practices will remove 100% of the risk of exposure to illnesses as most illness can be transmitted by persons who are asymptomatic and before some people show signs of infection. Everyone plays a crucial role in keeping everyone in the facility safe and reducing the risk of exposure by following our health policy, using proper handwashing techniques, and following local, state, and federal guidelines.

Parents/guardians are required to remove their children from carseats at the beginning of the day and place their children in carseats at the end of the day. Children must always be awake during the transfer of care from parents/guardians to Endless Discoveries staff in order to comply with safe sleep practices.

---

## Medications

---

While your child is in care, medications can be distributed within the following State of Texas guidelines:

1. Prescription medications must be in the original container labeled with the child's name, date, directions, and the physician's name. The label dosage must be followed unless otherwise instructed by a doctor.
2. Non-prescription medication must be in the original container and labeled with the child's name and date it was brought. Either a health personnel or the child's parent must approve the medication in writing. The label dosage must be followed unless otherwise instructed by a doctor. This includes all diaper cream.
3. Medications that are to be given twice daily (i.e., once in the morning and once at night) should be given at home by parents. Endless Discoveries will only administer medication per doctor's instructions to be given during school hours.

---

## Sunscreen and Insect Repellent

---

Endless Discoveries will apply sunscreen and insect repellent as needed. Sunscreen and insect repellent must be provided by the parent, in its original container, must not have expired, and labeled with the child's full name. A "Sunscreen/Insect Repellent Permission Slip" must be completed by the parent before these items can be applied. All children under the age of two must be provided sunscreen in a cream form, and children ages two and up must bring sunscreen in the aerosol form.

---

## Release Policy

---

Your child will be released only to the names listed on your enrollment form. For you and your child's security, we require a picture ID for any person we do not recognize. We also require a written permission from you for any person not listed on your enrollment form. Should an emergency arise during the day, you are to call with any necessary instructions and email the Director. In cases where the child is subject of a court order (custody order, restraining order, or protection of abuse order, for example), Endless Discoveries must have a certified copy and all amendments on file. The orders will be strictly followed. In the absence of the court order, both parents shall be afforded equal access to their child as stipulated by law. Endless Discoveries cannot limit the access of one parent by request of another parent, regardless of the reason. Parents/guardians must give Endless Discoveries written permission for any therapists or counselors that come in to work with your child during the day, and must be listed on the child's pick-up list to remove the child from our classroom setting.

---

## Anti-Idling Policy

---

Endless Discoveries prohibits vehicles outside of our center to idle for more than 5 minutes consecutively. This policy has been created to adhere to state laws and for the safety of children and the quality of air that they breathe.

---

## Procedures for Medical Emergencies

---

For parents' peace of mind, Endless Discoveries has procedures in place for emergencies. Listed below are the steps we will take for each situation. The full emergency preparedness plan is available in the office.

- Shelter and Intruder Drills: Shelter drills include bad weather and lock-down emergency preparedness. We will take refuge in hallways and bathrooms in the center of the building with a flashlight and a radio. We will stay there until bad weather passes or notified by authorities that the environment is safe.
- Fire, Explosion, Toxic Fumes, or Other Chemical Release: We will place infants and toddlers into the labeled fire beds and follow fire exit procedures shown on classroom walls. Older children will be escorted by their primary caregivers following fire procedures. Each classroom teacher will have their emergency book. The director will also have a school-wide emergency book as well as a cellular phone to contact emergency personnel and parents.

In the case of an emergency that requires Endless Discoveries Saginaw to evacuate the children from our facilities, we will relocate the children to American Bank, 825 North Saginaw Blvd., Saginaw, TX 76179. Endless Discoveries Glen Rose will relocate to 202 Bo Gibbs Blvd., Glen Rose, TX 76043. Endless Discoveries Hico will relocate to 106 College St., Hico, TX 76457. All staff and children will relocate by walking with a designated person leading and a designated person following after the center has been cleared of all persons. In this instance, parents will be notified via email, the parent communication application, phone call or text immediately and pick-up will be required within 45 minutes. In the event of a sheltering or lock-down emergency, the children will be relocated to the designated refuge locations until the Director gives further instructions. No one will be permitted to enter or leave the premises during this time. An emergency relocation diagram with instructions for staff is posted inside each classroom and available upon request. Staff have been trained, through the orientation process and drills, of care for the children if a situation requiring a lock-down occurs. Parents will be notified by the Director when children may be reunified with their families.

In the event the center needs to close, tuition will not be refunded or reduced for closures less than five days. If an extended closure past five school days occurs, all prepaid tuition will be refunded within 30 days. As we are unable to predict future scenarios and create policies for them, please understand that one of the core values of Endless Discoveries is fairness. We will always strive to make sure we are weighing the responsibility of the health and safety of our center in respect to our families and staff along with our financial responsibilities for the school and our staff to create a policy that works for the majority.

---

## Minimum Standards, Parents' Rights & Important Numbers

---

Every licensed child care center is required to follow detailed standards regarding the care of your child. These standards and the rights for all parents/guardians are available to read upon request. Additionally, the most recent licensing report on Endless Discoveries is available for all to read. Whereas the standards are in a digital format, the other documents are located with the center's Required Postings in the main foyer. All parties are able to review the child care facility's public records, inspection reports and can review the online compliance history. All concerns reported will be free from retaliation.

As a child care center, all staff are required to uphold the regulations and standards issued by the Texas Department of Health and Human Services Child Care Minimum Standards at all times. All staff are required to notify the management team immediately of any violations to the minimum standards by anyone in the organization. Additionally, we are mandated reporters to the Department of Human Services if we feel a child is being abused or neglected. Always be sure to let your child's teacher know when you drop your child off if he/she has any unexplained cuts or bruises. All children that come to Endless Discoveries with injuries will have them logged into the child's file. Parents may request to review written records of their children at any time. Additionally, parents may request to review any video recording per the policies and procedures listed on the "Camera Policies" form, however may not retain any part of the video recording depicting a child that is not their own. Any child that is captured in a video recording for review will receive written notice from the child care center before allowing another parent to review a recording.

To help prevent child abuse you need to understand what it is. It's any mistreatment of a child that results in harm or injury. There are four basic types of child abuse, though children often experience more than one kind of abuse. Examples of abuse include Physical Abuse, Emotional Abuse, Sexual Abuse and Neglect.

Children who are abused might show physical signs or sudden changes in their behavior or school performance. These signs don't prove that children are being abused, but they could be a signal that the children or their families need help.

General signs of abuse may include:

- Nervous around adults or afraid of certain adults.
- Reluctant to go home (come to school early or staying late, for example).
- Very passive and withdrawn or aggressive and disruptive.
- Tired a lot, or they might complain of nightmares or not sleeping well.
- Fearful and anxious.

Prevention techniques may include:

- Take a deep breath.
- Call someone or ask a friend to watch your kids while you calm down.
- Call the hotlines listed to find someone to talk to.
- Find a parenting class in your community to learn about ways to handle the stresses of dealing with kids.

---

## Transportation

---

Endless Discoveries will not provide transportation for children four and younger, with the exception of children enrolled in the Pre-Kindergarten program. Endless Discoveries will provide on-site learning activities for children not permitted to be transported. Infants and Toddlers may occasionally take walks in the four-seat stroller.

Endless Discoveries will provide transportation for children five and older to and from school, based on the needs of our families. If your child is scheduled to be picked up from a local elementary school and will not need transportation, you are required to notify Endless Discoveries an hour before the release of school. Non-notification will result in your account being charged \$10.

Additionally, Endless Discoveries will periodically take the School-Age children on field trips during school holidays and summer. All field trips will be posted 48 hours in advance, and all children wishing to attend must be signed up to go by their parent or legal guardian. In the event a child is not signed up, we will try to contact the parent/legal guardian for written permission, time permitting. If you do not want your child to participate in the field trip activities, alternative care will need to be arranged.

Our drivers are required to turn off the vehicle during children loading and unloading procedures.

---

## Water Play

---

Endless Discoveries will provide sprinkler play during the summer months and water table play year round. School-Age children may be taken to a pool or splash park during the summer field trips. All children will be required to swim in the shallow unless they express an interest otherwise. At that point, each child will be given a swim test by a certified lifeguard to establish their swimming ability. Any child who is marked on our paperwork who cannot swim will need to bring a US Coast Guard approved Type I, II, or III life jacket to wear during swimming field trips. These life jackets must be marked with your child's name.

---

## Pets

---

Each classroom will be given the option to have a class pet. Class pets must be aquarium kept and not handled by the children at any time.

---

## Security

---

Endless Discoveries is very secure, equipped with a door access system for entry through the front door. In order to enter our building, persons need to have either an active access key or an escort. No unfamiliar persons are able to enter the building without having a state/government issued ID. In the instance that your child is being picked up from Endless Discoveries-Saginaw, Building 2, and you do not have a card, you will need to come to the main office in Building 1 to be escorted by a member of management to your child's class.

With our door access system, each family is issued one access key upon enrollment. If an additional access key is needed, a charge of \$10.00 will be posted to the family's account, to be paid with the next tuition payment. In the case of withdrawal, the access key will be deactivated and need to be returned to the office.

One part of having a secure facility is not allowing others to enter that you don't recognize. For this reason, we ask that you do not hold the door for unknown persons out of kindness. Please allow a member of management to follow their process with visitors. Not following this procedure could result in the deactivation of your access key.

When visiting our facility for a tour, parents will be asked to complete an Inquiry Form. A state/government issued ID will be required to verify information on the Inquiry Form before a tour will be given and prior to enrollment paperwork passed out to the parent. We will make a copy of the state/government ID for our records.

---

## Camera Policies

---

Endless Discoveries Saginaw and Endless Discoveries Glen Rose are equipped with digital video security cameras and are installed in various parts of our building and outside areas that may conduct video surveillance of any portion of the premises at any time, excluding private areas of restrooms and changing areas. These cameras are placed strategically around the premises to help promote the safety and security of people and property. A video/audio/photo release of privacy rights for any child attending a facility operated by Endless Discoveries Child Development Center Series, LLC is a condition upon enrollment.

---

## Student Accident Policy

---

Endless Discoveries carries a student accident policy for children injured at the school.

---

## Yearly Updates

---

Every September, Endless Discoveries requires each family to review their enrollment information. It is imperative that emergency contacts and phone numbers are correct. We require any changes during the school year to be made in writing either through email or signed note.

---

## Gang-Free Zone

---

Endless Discoveries has a strict policy regarding the safety of our facilities and all who enter the premises. Endless Discoveries designates 1,000 feet from our center as a gang-free zone. Gang-related activity or engaging in organized criminal activity within 1,000 feet of Endless Discoveries is a violation of this law.

---

## Volunteers/Parent Chaperones

---

Volunteers and Parent Chaperones are welcome at Endless Discoveries. Volunteers are people who request to come into the center to either observe the children or work with the children. Volunteers are never counted into the teacher-to-child ratio; however, they can participate in activities with the children. Parent chaperones are parents who attend on- and off-site activities with their child. These activities may include class parties and field trips. To ensure the safety of the children in our care, all volunteers and chaperones will need to have a copy of their driver's license on file and a signed agreement of the code of conduct while participating in Endless Discoveries' sanctioned events. Additionally, all volunteers will be required to submit a background check, which is done at the cost of the volunteer.

---

## Not Permitted

---

Pursuant to Section 30.06, Penal Code (Trespass by Holder of a License to Carry a Concealed Handgun), a person licensed under Sub-chapter H, Chapter 411, Government Code (Concealed Handgun Law), may not enter this property with a concealed handgun.

Pursuant to Section 30.07, Penal Code (Trespass by Holder of a License to Carry a Concealed Handgun), a person licensed under Sub-chapter H, Chapter 411, Government Code (Concealed Handgun Law), may not enter this property with a concealed handgun.

In addition to firearms, hunting knives, bows and arrows, and other weapons are prohibited on the premises of the child care center. E-Cigarettes and vaporizers are restricted from entering the child care center.



# Our Programs

---

## Visitors

---

Endless Discoveries has an open door policy extended to every parent who has a child attending. These visits can be at anytime and do not require prior approval. It is the belief of Endless Discoveries that the most important people in your child's life are their parents and your involvement in their development is welcomed. Endless Discoveries welcomes visits by therapists and state and local personnel with prior approval from the enrolling sponsor in the child's file. All visitors must be announced by written communication with names and dates of approval. All visitors will submit their state/government issued ID for a copy for our records.

---

## Infant & Toddler Program (0-24 Months)

---

Endless Discoveries understands that it is difficult to leave your child in the care of someone other than yourself, but many families do not have any other option. Endless Discoveries is the perfect solution. We have personnel that are trained in CPR/First Aid, SIDS, Infant Brain Development, and Shaken Baby Syndrome, as well as other child development classes. Our teachers are caring to each child and treat each child as one of their own. We provide an environment that is safe, healthy, and stimulating to each child. A variety of activities allow for both active and quiet times throughout the day, in addition to the individualized care and lessons we provide for each child. Endless Discoveries also provides online daily communication to parents that describes their child's eating, sleeping, diapering, and developmental activities throughout the day. Teachers are also required to keep a portfolio for each child that highlights developmental accomplishments, growth, or funny incidents. We also love to take pictures of the children, which we will share with parents.

Endless Discoveries Child Development Center will provide a comfortable place with a seat for mothers to breastfeed their child if they choose to do so. Parents may also provide breast milk for their child to be served while in our care. Upon request, Endless Discoveries will provide breastfeeding education materials and support resources.

Our curriculum in this age group will be a mixture of several different curriculum books in order to get the best individualized lessons for each child. Some curriculum books will be:

## Preschool Program (2- to 4-Year Olds)

---

### Before-School and After-School Program (5- to 12-Year Olds)

---

At Endless Discoveries, school-age children (kindergarten through age 12) experience an innovative before- and after-school program. We tailor our program to a club environment so that children can independently find engaging activities that build on their natural curiosity. Our school-age program is broken down into three age specific groups so each child is able to develop social skills such as listening, sharing and cooperation with other children their age. We provide an environment that is safe, healthy and stimulating by allowing an ample area and activities that are fun and age-appropriate.

One of our goals is to find teachers that are caring to each child and treat each child as one of their own. It is important to us that we have teachers that are excited about teaching and can foster enriching activities. With an effective and positive style of guidance, energy, flexibility and a sense of humor, our teachers facilitate, guide and illustrate a love of learning that can be achieved through organized, fun activities.

Endless Discoveries provides transportation to and from local schools for the convenience of working parents. Additionally, we provide care during school breaks and strive to find fun and educational field trips during those breaks. For parents’ peace of mind, our buses are driven by employees with a clean driving record and insured through our insurance company. We drive the safest vehicles that are specialized by child care use and maintain a log to ensure repairs are done in a timely manner.

---

### Summer Camp (5- to 12-Year-Olds)

---

Endless Discoveries offers a Summer Camp program for all school-age children, providing a relaxed and balanced schedule with time to learn through play and engage in social activities with friends. A variety of clubs are offered with weekly meetings and stimulating activities.

Every two weeks, our Summer Camp has a new innovative theme, allowing children to exhibit their natural curiosity without getting bored. Our teachers prepare different games and activities based on each theme, with children choosing from a variety of activities that include quiet and active games with both small and large motor interaction. Our program also offers a range of field trips for off-site educational fun.

---

### Extracurricular Activities

---

Endless Discoveries offers a variety of different extracurricular programs throughout each month. These programs are offered separate from your family’s monthly tuition. Talk to the front office for more information on the extracurricular programs available.

---

### Encouragement of Physical Activity

---

Endless Discoveries strongly believes and supports the need for physical activity each day. Regular physical activity has many health benefits including building healthy bones and muscles, improving muscular strength and endurance, reducing the risk for developing chronic disease risk factors, improving self-esteem, and reducing stress and anxiety. Furthermore, increased academic performance has been linked to physical activity through dynamic interaction. All age groups will be given opportunities for physical activity both indoors and outdoors each day. Infants will have supervised tummy time along with other activities that engage their large motor muscles. Endless Discoveries will encourage moderate to vigorous activities such as running, climbing, jumping, and skipping, to the extent of their abilities. Toddlers will participate in a minimum of 60 minutes per day, Preschool through School-Age will participate in a minimum of 90 minutes per full day, and part-day School Age children will participate in a minimum of 30 minutes per day. Most opportunities for active play will occur during outdoor play, but teachers will have activities planned in advance for indoor active play as needed. All children will participate each day in:

- Two occasions of active play outdoors when weather permits.
- Two or more structured or teacher-led activities or games that promote movement over the course of the day.
- Continuous opportunities to develop and practice age-appropriate gross motor and movement skills.

When participating in physical activity, children’s clothing should protect them from sun exposure and permit easy movement (not too loose and not too tight) that enables full participation in active play. Footwear should provide support for running and climbing. Hats may be worn to protect children from sun exposure.

Examples of appropriate clothing/footwear include:

- Gym shoes or sturdy shoe equivalent.
- Clothing for the weather, such as a lightweight, breathable jacket without any hood and neck strings.



Examples of inappropriate clothing/footwear include:

- Footwear that can come off while running or that provides insufficient support for climbing.
- Clothing that can catch on playground equipment, such as those with drawstrings or loops.

---

### Supervised Rest Times

---

Every age group will have supervised rest times. Children birth to 12 months will be able to rest as needed throughout the day and our caregivers will periodically perform sleep checks. Infants will be put on their backs to sleep with nothing allowed in the bed, including blankets and stuffed animals, to avoid suffocation. A physician's note is required for a sleep positioning device. Children aged Toddler through Pre-Kinderergarten will have a blocked off time on their schedule from 12 pm until 2 pm to rest. Children are provided cots or mats with sheets and blankets that are washed weekly or as needed when soiled. School-Age children will be required to relax or rest for a minimum of 30 minutes during a full day of care.

---

### Child Assessments and Parent/Teacher Conferences

---

Child assessments and developmental checklists are completed when your child moves from one classroom to the next. During the month prior to your child transitioning, your child's current teacher will encourage each family to set up a time to meet to evaluate your child's progress in all developmental areas. The teacher may also note any areas of concern that, as a team in your child's development, Endless Discoveries would work with you on. Any additional time that your family would like to have a parent/teacher conference can be requested by written note or email. All child assessments are kept on file at Endless Discoveries, and a copy can be given to the family upon request.

---

### Discipline and Guidance

---

- Discipline must be:
  1. Individualized and consistent for each child;
  2. Appropriate to the child's level of understanding; and
  3. Directed toward teaching the child acceptable behavior and self-control.
- A caregiver may use only positive methods of discipline and guidance that encourages self-esteem, self-control, and self-direction, which include at least the following:
  1. Using praise and encouragement of good behavior instead of focusing only upon unacceptable behavior;
  2. Reminding a child of behavior expectations daily by using clear, positive statements; and
  3. Redirecting behavior using positive statements.
- There must be no harsh, cruel, or unusual treatment of any child. The following types of discipline and guidance are prohibited:
  1. Corporal punishment or threats of corporal punishment;
  2. Punishment associated with food, naps, or toilet training;
  3. Pinching, shaking, or biting a child;
  4. Hitting a child with a hand or instrument;
  5. Putting anything in or on a child's mouth;
  6. Humiliating, ridiculing, rejecting, or yelling at a child;
  7. Subjecting a child to harsh, abusive, or profane language;
  8. Placing a child in a locked or dark room, bathroom, or closet with the door closed; and
  9. Requiring a child to remain silent or inactive for inappropriately long periods of time for the child's age.
  10. Withholding physical active play or keeping a child inside as a consequence of behavior.

The four main points to highlight in Endless Discoveries' Discipline and Guidance Policy are:

- Treat each child with respect. Respect will promote positive attitudes towards caregivers and parents, as well as other adults in the child's life.
- Explanation of inappropriate behavior and expectations of appropriate behavior. This will promote an understanding of the behavior the caregiver wants to see from the child as well as why inappropriate behavior is not accepted.
- Consistency of rules among all caregivers. Consistency will help the child see that limit-testing will not be successful.
- Discipline will consist of redirection for smaller children or removal from the activity and friends for older children. Removal will be termed "Chill-Out Time," and the caregiver will express to the child: (1) what the child did wrong, (2) how the caregiver expects the child to act better, and (3) the choice to act better when the child is finished thinking about their inappropriate choices. The child will be in control of their own "Chill-Out Time."

In the event of consistent discipline issues with a child, where the child is a safety threat to themselves or others, the parent or guardian will be required to meet with the teacher and management staff to create a development plan for the child. Temporary suspension may be necessary to conduct all investigations and evaluations and/or securing outside support services. Endless Discoveries will collaborate with outside support services for any behavior, disability or developmental delay. The child may be required to be expelled if the dangerous behavior cannot be stopped by accommodations provided. It is our goal to work closely with all families to develop the whole child, so the decision of exclusion is never taken lightly.

# General Policies

---

## Fees

A non-refundable registration fee is charged at enrollment and on September 1st every year thereafter. For families that choose to pay weekly, tuition payment is due by Friday preceding the week of care. A late fee of \$10 is charged on Tuesday if payment has not been collected by Monday. Additionally, your child may not return on Tuesday unless payment is made. For families that choose to pay monthly, tuition payment is due monthly, payable in advance on the first business day of the month. A late payment fee of \$10 will be charged if payment has not been received by the end of the 2nd business day. Additionally, your child may not return on the 3rd business day unless payment is made. For any family enrolling in June or July, Endless Discoveries prorates the registration fee, with full registration due September 1st. Enrollments in August are not charged anything additional. A waiting list fee of \$50.00 is charged for every child hoping to be enrolled upon availability. This fee will be rolled into the registration fee when availability arises and the family would like to pursue enrollment. Tuition remains the same for months with absences or holidays.

---

## Payment Methods

You may pay by cash, money order, or personal check. Online bill-pay through Chase Zelle is also acceptable with your last name as the account number. A Chase Zelle payment can be made by using the email address of the Director of your center. Payment by credit and debit cards is also accepted at the sign-in kiosk and online at [www.myprocare.com](http://www.myprocare.com). This type of payment will be charged a convenience fee of 3% which will be calculated upon the total amount that is being paid. If insufficient funds occur, a \$25 fee will be charged to your account, and the full tuition in cash or money order will be due no later than one business day later. For accounts with two insufficient fund notices, cash or money orders will be required thereafter. We are unable to hold checks for a later date. All families are required to have a back-up account on file through Tuition Express. Tuition can be paid by any of the options listed above on or before the due date; however, if there is a balance remaining on the account on Tuesday at noon for weekly payers or on the 3rd business day at noon for monthly payers, the back-up account will be charged.

---

## Hours of Operation

Endless Discoveries Saginaw and Endless Discoveries Glen Rose will be available to care for children from 6:30 AM to 6:00 PM, Monday through Friday. Endless Discoveries Hico will be available to care for children Monday through Friday from 7:00 AM to 4:30 PM, with extended hours billed separately from 4:30 to 5:30 PM. Earlier and later schedules may be available at Endless Discoveries Glen Rose upon discussion with the management team. It is recommended that your child be restricted to 10 hours per day in child care for the welfare of your child. If your child will not be attending on any given day, a courtesy call is required by 9:00 AM. Children must arrive no later than 9:30 AM, unless previously discussed with the management team; however, late arrival may not occur during nap time. Late arrivals are a disruption to the classroom routine. If your child remains after the closing hours of the center, we will charge \$5 per child for every five minutes thereafter, to be collected upon arrival. After 10 minutes, if your child has still not been picked up, our staff will begin to contact every phone number listed on your child's enrollment paperwork. If no one can be contacted, Endless Discoveries is required to notify Child Protective Services (CPS) and the local police department.

---

## Sign In/Out Procedures

According to TDFPS guidelines, Endless Discoveries is required to keep on file when your child is dropped off, when your child is picked up, and by whom. Therefore, we require that you clock your child in and out with Procure Engage App or our sign-in kiosk located in the front of the school. All business must be completed prior to signing your children out. Once children are signed out, the parent is solely responsible for the care and well-being of their child. Our sign-in and sign-out kiosk is equipped with a biometric reader for ease of access. Please note that your biometrics will be stored in our system. If you would prefer to sign in and out with a code instead of with the biometric reader, please communicate that with the management team to assist. Children must be supervised at all times and may not wander through classrooms, bathrooms, hallways, or the playground area. Parents are required to leave the premises immediately after signing their child out.

---

## Personal Items

Parents will provide diapers, wipes, a change of clothes, diaper cream and a water cup. These items may be stored at the school and replenished as required. Each child will be provided a cubby to store all personal items. The center will keep diapers for instances where no diapers are brought. If we use a school-provided diaper, your child care account will be charged \$1 per diaper. Personal blankets and plush items are not allowed in our centers. Any modifications to this policy will be approved by the Director.

---

## Part-Week Schedule

The idea of part-week care is to allow all families the flexibility they need with the family/job balance. Our center attempts to match families that need 2 days per week with families that need 3 days per week and offset them to create a full-time enrollment. As the classroom fills up, please understand that it is our desire to provide the best possible care within each family's preferred schedule. However, if the classroom becomes full and cannot offset a family's particular schedule, we may ask for that family to move to full-time to keep enrollment for that child.

---

## School Calendar

Endless Discoveries will be closed for all major holidays including New Year's Day, President's Day, Memorial Day, 4th of July, Labor Day, Columbus Day, Thanksgiving Day and the day after, and Christmas Day and the day after. We will also close at noon on Christmas Eve. In the event that any holiday falls on a Saturday, Endless Discoveries will be closed the Friday prior to the holiday. In the event that any holiday falls on a Sunday, Endless Discoveries will observe it the Monday following. The monthly tuition will remain the same during the months with these holidays.

---

## Vacation

---

Endless Discoveries understands the importance of family time; therefore, we will offer each family the opportunity to have two weeks of vacation per year at a 50% discount that is equivalent to your child's active schedule. This week will be effective 6 months after your child's enrollment date to the anniversary thereafter. At that point, vacation time starts over again for the next year. The vacation days may be used as needed; however, Endless Discoveries prefers that the days are taken consecutively according to the Monday through Friday school week. Vacation does not apply to Summer Camp. Please give the director a two-week advance notification to help in monthly budgeting. Any other time your child is out will not result in a refund or prorated tuition.

---

## Meals, Snacks and Nutritional Needs

---

Endless Discoveries will provide morning and afternoon snack, lunch, milk and 100% juice. Our centers follow the meal patterns established by the U.S. Department of Agriculture (USDA) and the Child and Adult Care Food Program (CACFP) that is administered by the Texas Department of Agriculture. We ensure that 1) liquids and food hotter than 110 degrees Fahrenheit are kept out of reach, 2) all staff are educated on food allergies and they take precautions to ensure children are protected, and 3) prepared food is commercially prepared or prepared in a kitchen inspected by local health officials as applicable. Our menus are posted on our bulletin board in each classroom for your information. While children are in our care, they will be allowed to have second servings from the vegetable, fruit, grain, and milk group, and fresh water will always be available. These meals and drinks will count for some, but not all of your child's daily nutritional needs. You, the parent, must understand that Endless Discoveries is not responsible for meeting all of your child's daily food needs. Infants that are not ready for the food listed on our menu will be required to supply all bottles and jar food from home with instructions on the child's daily feeding schedule. Bottles must be pre-made with the child's name on the bottle. Our teaching staff will not be responsible for making any bottles. Parents with children suffering from food allergies or who have religious preferences may communicate their needs with the kitchen personnel and the office. All limitations, in regards to the food Endless Discoveries serves, must be documented in writing by the parent/guardian and the child's physician and received by management, the child's classroom, and the kitchen. Parents are responsible for supplying any/all substitutions of food/drinks. In this event, tuition will not be reduced or discounted. For all food brought from home, Endless Discoveries ensures the safety of the food in regards of maintaining proper temperatures. Endless Discoveries strictly prohibits any food made with nut products, sodas, candy bars and gum. To promote healthy eating habits, Endless Discoveries believes in Family Style Dining. This model will allow children to feed themselves upon their developmental level, offers an opportunity for caregivers to model appropriate dining etiquette, in a calm and unhurried manner. Family Style Dining will also allow children and caregivers to engage in communication that allows time to learn about healthy habits and personal individualized happenings while advocating good manners. In addition, Endless Discoveries has materials available upon request to all families from the USDA to help aid in healthy food habits and meal planning. This will include information on choking hazards, food allergies and other resources from [choosemyplate.gov](http://choosemyplate.gov).

---

## Bad Weather Days

---

When the local public school is closed for bad weather, Endless Discoveries will be closed as well. In the case of impending bad weather during the day, during the time your child is in care, you will be called to pick up your child as soon as possible. Additionally, if bad weather occurs when the public school is closed, the Director will make a decision based on the local news whether to close for the day or delay openings. Endless Discoveries is registered with NBC to communicate school closings or delay openings. A message will also be left on our answering machine and on social media channels with further information. There is no reduction in tuition for late openings or closures due to inclement weather.

---

## Personal Belongings

---

Endless Discoveries has a variety of safe and developmentally appropriate toys for the children to play with during their day. For that reason and because we would not like to see anything broken, we do not allow your child to bring toys or electronic devices into the center. If you would like to share a toy from home for all the children, ask your child's teacher first. No blankets or loose materials are provided for infants 0-12 months.

---

## Clothing

---

Endless Discoveries asks that all children wear comfortable, seasonal clothing that can be washed. As accidents may occur, we also ask that each child has a set of extra clothes that is labeled with your child's name. We require that all children wear closed toe shoes with backs. Sandals and flip-flops are not allowed, and any injuries resulting from wearing these shoes will not be covered by school insurance. Additionally, jewelry, hair beads, and barrettes are considered a safety hazard and will not be allowed.

---

## Non-Discriminating Policies

---

Endless Discoveries does not discriminate in its acceptance of clients on the basis of race, color, national origin, creed, disability, religion or gender. Furthermore, the school is an equal opportunity employer and does not discriminate on the basis of race, color, national origin, creed, disability, religion, gender or age in its hiring practices.

---

## Damages

---

If your child causes any damages, such as broken windows, you will be held responsible. This damage does not include toys your child plays with or other items specifically for child purposes.

---

## Withdrawal

---

If, for any reason, you decide to withdraw your child, a thirty-day written notice is required, with your account balances paid in full. If the required notice is not given, the account will be charged for two additional weeks equaling the amount of regular tuition. In the event of overpayment, Endless Discoveries will reimburse within 30 days.

---

## Special Needs Children

---

Endless Discoveries will make every effort to accommodate children with special needs, but the determination will be done on a case-by-case basis. If caring for one special child results in our staff not being able to also properly and safely supervise and care for our other children, we cannot accommodate that child. Endless Discoveries will discuss the special needs with the family in an informal interview. If deemed that Endless Discoveries can try to serve the family, the child's educational accommodations plan will need to be submitted so that Endless Discoveries can see the accommodations and adaptive equipment needed to provide care. If Endless Discoveries can make the accommodations, a

trial basis will be agreed upon by the Director and the family. If Endless Discoveries cannot fulfill further care for the child, the Director will start the process of disenrollment and assist the family in finding more suitable care.

---

## **Suspension and Expulsion of Children**

---

Endless Discoveries is proud of the history of working with the individual needs of each child and their families. Our center invites occupational and physical therapists during the day with prior communication and applicable clearances to work with children as well as making outside referrals to families as needed. However, any child who is a safety threat to themselves or others, or knowingly damages our facility may be subject to suspension and/or disenrollment from the center in accordance to all laws and regulations. Furthermore, any family member that shows disrespect to our center or staff in any way may be subject to this policy as well.

---

## **Grievance Procedures**

---

As an ongoing effort to improve communication, it is Endless Discoveries' belief that families with grievances must follow the chain of command and the procedures listed below.

1. The family must try to work out the issues of concern with the involved party on an informal basis.
2. The family must discuss the grievance with the Director as soon as possible after the issue of concern has arisen. The family may be asked to give a written description of the grievance. If the grievance involves the Director, the written grievance must be filed with the Owner.
3. A mediation meeting will be held to discuss the grievance and to brainstorm ways to solve the issue.
4. A follow-up meeting will be held to ensure a positive resolution for all parties.

If, as a result of this grievance, either the family or Endless Discoveries feels that the resolution does not meet their needs, the child may be withdrawn without the thirty-day written notice requirement. No refund of fees will be granted unless the Board Members of Endless Discoveries agree that proper steps of both parties were taken in order to resolve the concern.

In the case a refund is requested, a form must be filled out by the Director as to why the request has been made and the amount of the refund. The Director will submit the form to the Owner, which may take up to one month for a response. The Owner will notify in writing of the result.

---

## **Program Improvement**

---

Endless Discoveries will send out quarterly surveys to both parents and staff. These surveys will encourage the participants to discuss improvements that can be made to the school or to the program itself. All improvements or suggestions that are made will be typed and posted on the Parent Board. Additionally, suggestions can be made anonymously through our website.

---

## **Use of Media**

---

Endless Discoveries believes that children have many opportunities for learning other than with the use of media. Our Pre-Kindergarten classrooms may use a smart tablet to supplement lessons in conjunction with Hatch Early Learning with pre-loaded educational, developmentally-appropriate curriculum.

We do not promote watching television at Endless Discoveries. On occasion, your child's classroom may watch a movie, but it is required to be part of their lesson plan and have discussion afterward. All movies must be posted 24 hours in advance. If you do not want your child to watch the movie, we will provide another activity for your child during that time. School-age children are allowed to watch movies on school holidays and special events.

As a requirement set forth by TDFPS and an ongoing effort to limit electronic media to 90 minutes per day, children are not allowed to bring devices such as phones, tablets, etc. Any devices brought into Endless Discoveries will be asked to be put away; however, if it becomes a problem, they will be taken away and placed in the front office for pick-up by the parent or guardian.

---

## **Employment and Social Media between Staff and Clients**

---

Clients often form close relationships with their children's caregivers. Whereas Endless Discoveries encourages this on many levels, the rules for preservation of the company must be acknowledged. Employment of Endless Discoveries staff is defined but not limited to babysitting, housesitting, nanny services, and carpooling regardless of payment of those services. Staff and clients that engage in an employment relationship must understand that Endless Discoveries is not liable for actions of the staff member and/or incidents after hours or off company owned property. This also includes utilizing Parents' Night Out as a babysitting option when offered.

Endless Discoveries requires all staff to agree to a non-compete agreement prior to employment. It reads as follows: "The employee agrees not to compete with Endless Discoveries Child Development Center Series, LLC, in the practice of child care while working for the company and for a period of two years after termination of employment within a radius of ten miles of Endless Discoveries Saginaw, 823 Towne Court, Saginaw, Texas 76179, a radius of ten miles of Endless Discoveries Glen Rose, 200 Commerce Street, Glen Rose, Texas 76043, and a radius of ten miles of Endless Discoveries Hico, 614 Kirk Street, Hico, Texas 76459. For the purposes of this Non-compete Agreement, competition is defined as soliciting or accepting employment by, or rendering professional services to, any person or organization that is or was a client of Endless Discoveries during the term of employee's work with the company. This does not pertain to babysitting activities after hours or on the weekend." Endless Discoveries will pursue legal actions in this event against both parties.

Social networking relationships are allowed, but all parties need to be aware of the risks involved. Endless Discoveries staff are required to be professional at all times, and reports to the company proving otherwise may put the staff member's job in jeopardy. Likewise, comments and/or posts that are deemed negative made by clients are subject to review and may result in exclusion or possible further legal actions.

---

### **Legal Requests**

---

Endless Discoveries will refrain from engaging in legal disputes. We can provide financial and/or attendance records to the payers listed on the account; however, additional information will require a court ordered subpoena.

---

### **Pictures Taken Within the Centers**

---

Parents are only allowed to take pictures of their own child at events held by Endless Discoveries, unless given written permission by the other parent. During certain public events, such as carnivals and class programs, participants may be photographed inadvertently, and anyone that wishes for their child not to be photographed may want to remove them from these events.

---

### **Parent/Guardian Code of Conduct**

---

Just as Endless Discoveries has a strict code of conduct for all staff, we must maintain the same for our parents/guardians. While on Endless Discoveries properties, all parents/guardians must agree to refrain from the following:

- Swearing/cursing
- Threatening staff, other parents, and confrontational interactions
- Physical and/or verbal punishment
- Cell phone usage, and,
- Lack of confidentiality

Parents/Guardians who engage in any of the listed activities will be asked to leave the property and may be asked to find alternative care.
